

Minimum Eligibility Criteria

- i. Pakistani/AJK nationals.
- ii. Candidates must have minimum sixteen (16) years of education and terminal qualifications in Medical/ Dental Disciplines as per HEC criteria.
- iii. Minimum 50% of marks are required in NTS test (GAT-General) for shortlisting **OR the candidates who have not appeared in NTS test also can apply but they have to appear in Subjective Test conducted by the University.**
- iv. Maximum one second divisions throughout the academic career.
- v. Maximum age for availing scholarship:
 - ✓ 40 years for **full time regular faculty members** of public sector Universities/Colleges and employees of the public sector R & D organizations.
 - ✓ 35 years for all others.
- vi. The candidates who are already availing any other SMBBMU/Govt. scholarship offer are not eligible to apply.

Application Procedure

The following documents are required to be submitted along with the printed copy of application form:

- i. Attested photocopies of all educational testimonials.
- ii. Attested photocopy of CNIC
- iii. Attested photocopy of domicile.
- iv. Front Page of Passport.
- v. CV/Resume.
- vi. Statement of Purpose (one page only).
- vii. Copy of PMDC Registration.
- viii. Research Proposal Abstract.
- ix. Attested Copy of GAT (General) result card (*If available*).
- x. NOC from the employer for **in-service candidates** (only for Government employees).
- xi. Original Deposit slip of Rs. 2000/- (non-refundable) in favor of the Vice Chancellor, SMBBMU, Larkana. **Sindh Bank VIP ROAD Branch. A/c No. 0107_003225_6100**

(Note: Those who have already submitted Rs. 2000/= last year along with their application need not to submit draft again.)

Important Note

- i. All scholarships will be awarded on merit.
- ii. Candidates having direct admission in Ph.D. will be preferred.
- iii. Incomplete applications or those received after the closing date will not be entertained.
- iv. **In-service candidates should apply through proper channel advance copies will not be entertained.**
- v. Awardees of the Scholarships (Fresh and In-service on probation) shall not be paid salaries during the period of study leave.
- vi. Candidates are required to fulfill the requirement of Host University to secure the admission which may include International GRE, TOFEL etc. Candidates are advised to appear in these tests before the interview / admission.
- vii. Only short listed candidates will be called for interviews.
- viii. SMBBMU reserves the right to allocate any country / any university to the candidate/ cancel the seats.

Terms and Conditions for award of HEC Overseas Scholarship Programs

The following are the terms & conditions of the award of scholarship and the acceptance of the award is an acknowledgement of these obligations:

- i. An awardee will not change the course of study specified in the letter of award without obtaining prior approval of the Competent Authority.
- ii. An awardee is not to hold any other scholarship/stipend during this scholarship period of his/her study.
- iii. A change of university/institute during the study will only be admissible with the prior approval of the Competent Authority.
- iv. An awardee would obtain leave from his employer to join the institution of his study on full-time basis.
- v. An awardee is required to execute a bond with the university/institution of his employment to serve his parent department for 5 years subsequent to the award of the Degree.
- vi. An awardee shall sign an agreement with the SMBBMU on non-judicial (stamp) paper to the effect that in case the awardee fails to complete his/her study, he/she will refund double of total amount spent on his/her studies by the SMBBMU. ***The format of the agreement is given as a specimen.***
- vii. In addition, a personal guarantee of a person of means on non-judicial (stamp) paper to the effect of ensuring the recovery in case of default would need to be furnished. ***Specimen is attached.***
- viii. Every document i.e. Deed of Agreement, Guarantee to SMBBMU, Declaration of Assets, Certification of Financial Soundness and Surety BOND must be properly notarized, that means the document must be registered by the Notary Public maintained by him as Notary register and the signatures of the executant must be obtained on the register and the number of the registration must be mentioned along with the notarial stamp.

DEED OF AGREEMENT FOR UNDERTAKING A COURSE OF STUDIES SCHOLARSHIP UNDER (Establishment of SMBB Medical University, Larkana)

in the SMBBMU, hereinafter called the SMBBMU. WHEREAS Mr. / Ms.
.....has been selected by the SMBBMU, Larkana for the
award of Scholarship for ...(Please fill name of Subject for which Scholarship is being

..... under the Project: Establishment of SMBB Medical
University, Larkana and the scholar has agreed to accept the same on the terms and conditions
governing this scholarship award.

Now this deed witnesses as under:

- i) This scholarship award shall be initially valid for one year and may be renewed up to a maximum total duration of two years for Masters and three years for Ph.D. degree subject to satisfactory academic performance of the scholar.
- ii) The payment of allowances admissible under the scholarship program shall be made subject to the complete adherence to all rules and regulations governing the scholarship program as well as satisfactory performance in the authorized studies.
- iii) The scholar shall not change the specified course of studies nor register himself/herself for any other course or program without prior approval of the SMBB Medical University, Larkana.
- iv) The scholar shall not extend the specified period of studies without prior approval of the SMBB Medical University, Larkana.
- v) The scholar shall not undertake employment whether paid or otherwise without approval of the SMBB Medical University, Larkana during his/her course of studies abroad.

- vi) The scholar shall refrain from engaging himself/herself in any political, commercial or any other activity incompatible with his/her program of studies abroad.
- vii) In case the scholar fails to qualify the course for which he/she was awarded Scholarship, the SMBBMU reserves the right to recover entire expenditure inclusive of travel cost from the Scholars/Guarantor.
- viii) The scholar shall return to Pakistan immediately after the completion of the approved course for which he/she was sent abroad, and shall serve in SMBBMU, Larkana for a period of five years as may be prescribed.
- ix) The scholars shall contact SMBBMU immediately after his/her return to Pakistan and would inform about his/her employment/posting with date of joining.
- x) The scholar shall not incur any debts during his/her stay abroad and will clear all outstanding bills before leaving the country of study/training/research.
- xi) The scholar shall regularly submit the quarterly progress reports on his/her assigned Program abroad to the SMBBMU and a final comprehensive report immediately on completion of the study/training/research.
- xii) The scholar will be liable to disciplinary action as follows:
 - a) If he/she fails to avail of the award without any cogent reason acceptable to SMBBMU/HEC, he/she will be debarred from further study/training/research abroad under any Scholarship Program. If any financial loss is sustained as a result of his/her failing thus to avail the award, he/she will be held responsible therefore and liable to make good the same, apart from being liable to any penalty to be imposed by the Scholarship Management Committee (SMC) in this behalf.
 - b) If he/she fails to comply with the instructions/orders of SMBBMU for proceeding abroad without any cogent reason acceptable to SMBBMU, he/she will be liable to reimburse the Scholarship Management Committee (SMC), on demand, the amount of passage money spent either by the country to be visited or SMBBMU or both, in connection with his/her scheduled visit abroad.
 - c) If he/she fails to obey or act in accordance with SMBBMU's order directing him/her to return to Pakistan, he/she will be liable to action under the acts/rules in force in Pakistan impounding or confiscating passports.
 - d) If he/she violates any condition laid down in the Bond for studies/training abroad under the Scholarships Program, he/she will be liable to pay the penalty as prescribed therein.
- xiii) The scholar is liable to disqualification from foreign training or such other disciplinary action as SMBBMU may consider appropriate, if:
 - i) He/she violates any of the foregoing conditions, or
 - ii) He/she is found to have made any misstatement therein before.

AND THE SCHOLAR FURTHER COVENANTS, that in case of breach of any of the above terms and conditions as well as the rules / terms and conditions those governing scholarship award and / or his / her failure to return to and serve in Pakistan as directed by the SMBBMU for the specified period, the scholar shall be bound to pay the SMBBMU a penalty as prescribed by the SMBBMU besides compensate the SMBBMU by making a refund of the total amount of expenditure including travel cost incurred on him / her in Pakistan Rupees and in foreign

currency or its equivalent in Pakistan Rupees at the official rate of exchange prevalent on the date of the breach of the above agreement. The amount of penalty and the compensation as prescribed and assessed by the SMBBMU shall be final and conclusive.
