1. Valid Registration with Income tax, Sales Tax, Sindh Revenue Board, Pakistan Engineering Council in C-4 category (Civil codes-CE-09 & CE-10 and Electric Codes EE-04, EE-06, EE-11) and Valid Electrical License obtained from concerned region (Larkana) .
