Bidders will submit two sealed envelopes simultaneously; the sealed bids shall comprise a single package containing two separate sealed envelopes. Each sealed envelope shall contain separately the financial proposal and the technical proposal;


The sealed envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion along with signature & rubber stamp of firm, enclosed together in an sealed outer single envelope, initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened, the envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the procuring agency without being opened; the financial bids shall only be opened of technically qualified firms publicly at a time, date and venue announced and communicated to the bidders in advance; financial bids of technically disqualified firms shall be returned unopened; in consonance with Rule-36(b) of PPRA 2004. The submission of bids to the office of the undersigned on 07.02.2022 till 12:00 noon, 'TECHNICAL PROPOSAL' will be opened at 12:30 p.m on the same day in the presence of participants (who may choose to attend).
